1 **WHEREAS**, Section 610 of the Howard County Charter authorizes and
2 empowers the Howard County Council to make supplementary appropriations from the
3 unexpended and unencumbered funds set aside for contingencies in the County budget;

6 **WHEREAS**, the Circuit Court for Howard County has been awarded a grant
7 from the Maryland State Law Library in the amount of \$20,000 to improve the equipment
8 and technology in the Circuit Court’s library, to create a small duplicate collection for
9 heavily used books, and to provide professional development for the law librarian; and

11 **WHEREAS**, the Director of Finance has certified that the appropriation to be
12 transferred is not encumbered and is available for transfer.
