1           **WHEREAS**, Section 610 of the Howard County Charter authorizes and  
2 empowers the Howard County Council to make supplementary appropriations from the  
3 unexpended and unencumbered funds set aside for contingencies in the County budget;

7 amount of \$10,000 from the Maryland Department of Agriculture; and

9           **WHEREAS**, the grant funding will be used for the Noxious Weeds Program to  
10 control and eradicate certain designated weed species including Johnson grass,  
11 shattercane, thistle, and multiflora rose; and

13           **WHEREAS**, the Director of Finance has certified that the appropriation to be  
14 transferred is not encumbered and is available for transfer.
