Directions:

WILDE LAKE MIDDLE - 10481 Cross Fox Lane, Columbia, MD 21044. From Route 29 South, take Columbia Town Center exit (Route 175) to Little Patuxent Parkway. Bear right onto Governor Warfield Parkway. Go to second signal light (Twin Rivers Road) turn right. Make a left on Trumpeter Road (just before Interfaith Center). Located next to Wilde Lake High School (see above directions). Follow road to the right.

Sign-In / Sign-Out Procedures:

- Parents must enter the school and sign your child/ren in and out each day.
- Please be prompt when picking up your child.
- Late fees will be assessed at \$5.00 for the first fifteen minutes late, and \$1.00 for each additional minute late.
