**Robbery**

A store employee reported that two male suspects with their faces partially covered entered the store, jumped the pharmacy counter, and demanded prescription medication. The suspects pepper sprayed two other employees before fleeing with the medication. The two employees were transported to the hospital for treatment. The investigation is ongoing.
