Robbery arrest update

Police have made an arrest in two robberies in October in the 9100 block of All Saints Road in Laurel. Nortel Clayton, 29, of Canterbury Riding in Laurel, was charged with armed robbery, robbery, attempted robbery, theft, attempted theft and assault.

On Oct. 23 at approximately 8:16 p.m., the suspect entered the Dollar Plus, approached the counter, implied a weapon and stole cash from the register before fleeing. No one was injured. On Oct. 28 at approximately 1:11 p.m., the suspect entered the Urban Market, approached the counter, implied a weapon and demanded cash. The employee refused and the suspect fled when an alarm was activated. No one was injured and nothing was stolen. Through investigation, police identified the suspect and determined he was responsible for both robberies.
