Robbery arrest update

Police have arrested a suspect in a Nov. 30 robbery in Laurel. An adult male victim reported that he arranged online to sell a cell phone and met with a male suspect in the 9600 block of Washington Avenue. The suspect then displayed a handgun, stole the phone, and fled. No one was injured. Through investigation, police identified the suspect and arrested him.

Opioid overdose

Since the Fri., Dec. 1 daily crime bulletin, police responded to a non-fatal overdose. Naloxone, also known as Narcan, was administered. Narcan is a medication that reverses the effect of an opioid overdose. The person was transported to the hospital for treatment.

2017 YTD Total Overdoses:

Fatal: 53*

Non-Fatal: 156

*In fatal cases, some deaths are pending autopsy results for opioids and/or other substances. Numbers may fluctuate.

Of the 156 non-fatal opioid overdoses, life-saving Narcan was administered in 141 incidents.
