ARREST: Home invasion/weapon violation update

Update to the below entry from the Friday, April 24, daily bulletin. Jeremiah Jordan McLeod, 28, of Henderson Avenue in Silver Spring, has been charged with home invasion, burglary, and assault.

Laurel, 20723: 9400 block of Canterbury Riding, April 24 12:35 a.m.

A male victim reported that a male suspect entered his bedroom and displayed a handgun. The victim, along with other residents, were able to disarm the suspect. Police responded and arrested the suspect, who was transported to the hospital for minor injuries sustained in the altercation. Charges against him are pending. The gun was determined to be a BB gun.

Weapon violation

Police responded for a report of an attempted burglary, and upon arrival heard gunshots nearby. They discovered a vehicle with several bullet holes. No occupants of the vehicle were injured. A short time later, they learned of an additional vehicle that had been shot at near Route 175 and I-95. No occupants of that vehicle were injured. Police believe both shootings are related and are investigating the circumstances.
