Robbery

Laurel, 20723: Kake Korner, 10000 block of Washington Boulevard, Apr. 27 10:30 a.m.
Multiple victims reported that three male suspects with their faces partially covered entered the store and announced a robbery. One suspect displayed a handgun, and the suspects stole cash, electronics and other items from two customers and the business before fleeing. No one was injured. Through investigation, police identified two suspects, who were then arrested in a neighboring jurisdiction. ARRESTED: Ronald Lewis Dees III, 22, of Virginia Avenue in Baltimore, and Tavione Hooks, 17, of Green Spring Avenue in Gwynn Oak, charged with armed robbery, robbery, and theft. Hooks is being charged as an adult.
SUSPECT: black male, 6'0", with a thin/medium build, wearing dark clothing
