Non commercial robbery

Laurel, 20723: 5700 block of All Saints Road, July 3, 9:00 p.m. (attempt)

An adult male victim reported a group of suspects approached him while he was playing basketball and demanded his belongings. When the victim refused, one suspect threatened him with a handgun and others assaulted him. The suspects then fled. Nothing was stolen. No serious injuries.

Assault, attempted burglary

An adult victim and a teenage victim were involved in a dispute with acquaintances at the Oakland Mills Village Center. The suspects threatened the victims with knives and chased one victim into his residence. The suspects broke a window in an attempt to gain entry but were unsuccessful. Police responded, located and arrested the suspects. No serious injuries.
