2020 APPLICATION FOR PROPERTY TAX CREDIT LAND IN AGRICULTURAL LAND PRESERVATION PROGRAM DEADLINE: JULY 31, 2020

The annotated Code of Maryland, Tax-Property Article Sections 9-206 and 9-315 provide for a property tax credit to be granted, upon application, to an owner of agricultural land to which an easement has been permanently conveyed or assigned to the Maryland Agricultural Land Preservation Foundation or the Howard County Agricultural Land Preservation Program. The credit shall equal 75 percent of any County property tax imposed on the land included in such easement, not including any improvements. An eligible owner of agricultural land shall apply for tax credit with the Director of Finance within 30 days of the issuance of each annual property tax bill. A credit is given on your tax bill for the first <u>full</u> tax year after easement settlement. HOWARD COUNTY CODE SECTION 20.122
