2024-2025 LIQUOR LICENSE RENEWAL INSTRUCTIONS

TO ALL LICENSE HOLDERS:

The 2023-2024 alcoholic beverage license for your business will expire **April 30, 2024.** Below you will find a link for an online renewal application which must be filled out **completely by March 30, 2024.** Once your renewal application is approved, you may pay online; mail; or drop off a check for your annual fee between March 1, 2024 and April 1, 2024.

<u>PLEASE NOTE – THE LINK WILL NOT WORK UNTIL MARCH 1ST. YOU WILL NOT BE</u> ABLE TO RENEW BEFORE THEN!

The amount of the fee for your establishment is listed below under <u>CLASSES AND FEES</u> and may be found in the Rules and Regulations for the Board of License Commissioners and the Alcoholic Beverage Hearing Board. Additionally, the renewal fee will populate in the online renewal application.

Please make the check payable to **Director of Finance for Howard County. Mail** to: **Board of License Commissioners**, c/o Board Administrator, 3430 Court House Drive, Ellicott City, Maryland 21043.

Applications for renewal of licenses must be filed between March 1st and April 1st of each year. Failure to do so shall result in non-renewal of the license or a **penalty of \$50 per day** after April 1, 2024 for every day the application is late. The late application must be completed by *May 1 by 5 p.m.* or a license expires by operation of law and may not be renewed.

Incomplete applications will not be processed, and paper copies will not be accepted.

Upon approval and after renewal fee is paid, the 2024-2025 Liquor License will be emailed to all licensees as a PDF attachment to print, beginning the week of **April 15th**, **2024.** If you have questions or need help accessing the online renewal application, please email kberg@howardcountymd.gov or call (410) 313-3114.

CLASS B or D - REQUIRED DOCUMENTATION

Along with the renewal application, **licensees holding a Class B or a Class D license** shall submit the annual sales from his/her Certified Public Accountant, or equivalent statement, certifying the percentage of gross revenue from the sale of food and the percentage of gross revenue from the sale of alcoholic beverages for the purpose of ensuring the renewal of the proper class of license.

HOLDS ON LIQUOR LICENSE ACCOUNTS

Any holds place by the Fire Inspector <u>must be completed prior</u> to your renewal being issued. In addition, any delinquent taxes due and owed to the State of Maryland or Howard County <u>must be paid</u> <u>prior</u> to the renewal of your license. These taxes include Maryland Withholding Tax, Admission and Amusement Tax and Retail Sales Tax.

A Class D tavern license issued prior to November 1, 1981, may continue to be renewed on the same terms and conditions in effect at that time.
