APPLICATION FOR PROPERTY TAX CREDIT LAND IN AGRICULTURAL LAND PRESERVATION PROGRAM DEADLINE: APRIL 1

The Annotated Code of Maryland, Tax-Property Article Sections 9-206 and 9-315, and §20.122 of the Howard County Code, provide for a property tax credit to be granted, upon application, to an owner of agricultural land where an easement has been permanently conveyed or assigned to the Maryland Agricultural Land Preservation Foundation or the Howard County Agricultural Land Preservation Program. The credit shall equal 75 percent of any County property tax imposed on the land included in such easement, not including any improvements. A property owner who becomes eligible shall initially apply for a credit with the Director of Finance on or before April 1 preceding the new tax year. A credit is given on your tax bill for the first <u>full</u> tax year after easement settlement.
