Sewer Connection 4"& 6" - \$4,500.00; 8" & larger @ cost, minimum of \$4,500.00 by Advance Deposit Order.

AD VALOREM CHARGE

Point zero eight dollars (\$0.08) per each \$100.00 of Assessed Valuation upon all property, located within the Metropolitan District.

GENERAL SYSTEM BENEFIT CHARGE

Point zero eight dollars (\$0.08) per each \$100.00 of Assessed Valuation upon all property, located outside the Metropolitan District connected by order of the Health Department.

FIRE AND RESCUE TAX RATE

Metropolitan/Rural District Point one seven six dollars (\$0.176) per each \$100.00 assessed valuation of real property.
Point forty four dollars (\$0.44) per \$100.00 assessed valuation of personal property & operating real property.
