Presentation	Laura Torres, Behavioral Health Program Manager, Howard County General Hospital (HCGH) — Behavioral Health (BH) in the Emergency Department (ED) begins with a person being seen by triage, then evaluated by a nurse and ultimately seen by the attending physician to determine if they are cleared for discharge or if they need to have a psych consult conducted by a psychiatric social worker. One of the challenges is the lengthy amount of a time a psych patient may have to wait in order to be treated. There are typically 1-3 psych social workers per shift and each evaluation take 1-4 hours. Once the evaluation is completed, the psych social worker will develop a disposition or discharge plan for the patient. The HCGH ED is a 5 bed BH unit staffed with 1 nurse, 1 medical tech and 1 security guard. When the BH unit is full, the BH patients are placed in medical ED beds which delays treatment for patients who only need medical care. Pediatric ED has 5 beds in a secure area for BH patients who are ages 17 and younger. Some of the challenges for the licensed clinical social workers includes: time

constraints, difficult to connect with outpatient providers, reevaluations within 24 hours and the volume of patients. There is a statewide delay in BH patients who are to be discharged or need to be transferred for inpatient treatment which include awaiting bed space, waiting for agency acceptance, Medicaid or ambulance transportation delay, placement setting refuses or denies patient and delay in creating a plan. Disposition options include: discharge home with a referral for outpatient services, voluntary admission to an inpatient unit or involuntary admission to an inpatient unit. To help the process along, HCGH has BH Navigators to assist with discharge planning by providing referrals, setting appointments for care, connecting patients to additional resources, helping to address other barriers and reconnecting with patients for follow up. Peer Recovery Coaches, who are employed by the Health Department, also work in the ED to help patients with substance use disorder challenges.


Shereen reported the following:

- The 211 Outpatient Care Coordination Program launched in partnership with the Maryland Department of Health (MDH), the Behavioral Health Administration (BHA).
 - The goal of the program is to support Discharge
 Planners/Care Coordination Teams in Emergency
 Departments (EDs) to easily connect their patients with the appropriate, community-based appointments (or referrals) for behavioral health services.
 - The program is currently accepting referrals in Baltimore City and will expand statewide by October 2022.

- CAMS Care trainings Sept 23 and Oct 17
 - oCollaborative Assessment and Management of Suicidality (CAMS) framework (www.cams-care.org). CAMS-Care is an evidence-based suicide prevention model that has been shown to be effective in reducing suicidal ideation and intentional self-harm in an outpatient setting. Training clinicians in the CAMS suicide assessment and intervention framework will increase the capacity of local providers to address suicidality and divert patients away from emergency services for treatment.
 - o The HCHD/LBHA is seeking to recruit local mental health clinicians and behavioral health providers to participate in the FY23 CAMS-Care training. The HCHD/LBHA will pay for all costs associated with the CAMS-Care training, which is valued at \$335.
